Advanced Microeconomics I: Syllabus

Prerequisite: Calculus, Probability, Intermediate Microeconomics, Basic Game Theory.

Course description: In this course, we mainly talk about the information economics. The first part is the theory of incentives (or the contract theory), including adverse selection, moral hazard, and nonverifiability. The second part is the information transmission, including signaling, cheap talk, Blackwell experiment, Bayesian persuasion, and herding.

We try to provide a systematic understanding of the form and the consequences of these economic interactions by describing and analyzing them with the use of a theoretical framework. These models will help us gain insights in understanding how individuals interact in certain novel situations, and allow us to draw conclusions on what outcomes to expect from their interactions.

We will not cover the core part of mechanism design, which is the main focus of Advanced Microeconomics II.
